# Important changes

As you know, the Ascentric platform was purchased by M&G plc in September 2020 and we became part of the newly launched M&G Wealth. Last year we rebranded our website, marketing emails and social media channels, and this year we're rolling out the final phase of the rebrand programme.

We're now getting closer to completing this last phase. Over the next few months the platform and literature will be rebranded to M&G Wealth and the old Ascentric logo will be removed.

Here's what's happening over the next few weeks.

## Contacting your clients

As we did at the time of the sale to M&G plc, we'll be contacting your clients to let them know about the changes to the brand. As well as raising awareness of the rebranding of the platform and literature, we'll also be letting them know about some minor Term changes including the change to our registered address. This communication will be sent, next week, depending on their contact preferences.

The full details on what's been updated in the Terms will be included in the Quarterly Valuation Statement communications in July.
